The Customs Stamp Duty is still payable though.</li> <li>• SEA consignments with a Valued Inventory of 5000 USD and above need an Import License. Import Licenses are only granted to Importers dully registered in the REIS list.</li> <li>• On some occasions, customs may require an inspection of a Diplomatic consignment. Returning Angolan Diplomats pay duties and taxes on their vehicles.</li> <li>Consignments including a car need an Import License. Import Licenses are only granted to Importers duly registered in the REIS list.</li> </ul>	<ul style="list-style-type: none"> <li>Customs clearance takes <b>20 to 30 business days</b> from receipt of all requirements before final delivery.</li> <li>Vehicles (even Diplomatic) shipped in containers are systematically offloaded at a Customs managed depot. If HHGDS are shipped together with a vehicle, these will be offloaded from the container as well and kept in a Customs managed bonded warehouse. This also applies to Diplomatic shipments.</li> <li>Storage, demurrages, and other unwanted charges are inevitable in Angola and are absolutely outrageous.
